Meeting called to order at 6pm by President, Christine Culligan

All accounts, including EHT Operational Account and all travel accounts, have been moved from TD to Fulton Bank. All accounts have been closed at TD Bank.

**VP's Report:** JR Gentile suggests to merge Field Maintenance and Field Coordinator positions. From JR's personal experience, the duties of the two positions can easily be combined. JR shares his perspective that while taking an interim for both positions during the fall season, it was easy to work with Rob, communicate about schedules and field upkeep. C.Culligan notes that JR has been doing an outstanding job so far, and should fill in the field Maintenance and Field Coordinator positions, until the right person who can commit to those duties, volunteers to take over.

JR suggests a purchase of a towable wagon for the fields from Tractor Supply.  
Rob is picking up the golf carts by the end of the week, will fix and bring them back.

**President's report:** C.Culligan has attended the Rec Board Meeting. From now on, the rec board meetings will be held at the court, recorded and held in a different format. All the complaints, requests and suggestions of the members will be heard during those meetings, but not immediately addressed. On the Rec board website, there are links to nominate Coach of the Year and Unsung Hero.

We've registered, paid and set for the All Stars through Babe Ruth, saving \$100 for the early bird special.

**Travel:** 18U Sarni and 18U Strothers combined the teams.

H.Devine has reached out to the travel coaches requesting them to submit their rosters online, on our website [www.ehtsoftball.com](http://www.ehtsoftball.com), along with registering every coach, including the assistant coaches. H.Devine is working on creating individual team pages where the members will be able to access the team info, calendar etc.

#### **Tournaments:**

The payment with a credit card option has not even been available through TourneyMachine. H.Devine is working on setting this feature up.

V. Glick did the inventory of the rec equipment; she suggests a purchase of grip tape to reward the bats, new helmets (should be updated every 3 years for safety purposes). There are 3 pitching machines. J.Gonzalez suggests that the shared equipment like sliding mats, pitching machines etc should have a sign up sheet for the coaches to encourage a responsible use of the expensive equipment.

**Rec Spring season:** Anthony from Brigantine is the new head of ABRSL, they didn't express any concerns with EHT coming back to play in ABRSL in spring again. C.Culligan says Haley will hold two clinics, pitching and the other one is for fielding.

Sign ups will close on February, 8. K.Sutor offers to look into putting the EHTYS flyer on the EHT middle and elementary schools' webpage.

JR Gentile suggests that at the upcoming Rec Coaches meeting, the Board members should hold some type of a coaches clinic where some aspects of coaching can be discussed: teaching fundamentals, building consistency across the teams and rules within EHTYS organization,

introducing new strategies and expectations for the season, and addressing the importance of the communication when it comes to coaching children and interaction with the Board. The Board members agree that a Fundraiser Committee should be formed.

C.Culligan is nominated and accepted her nomination as the President. All the voting members agree unanimously to keep C.Culligan as the President. E.Muniir is nominated and accepts her nomination as the Treasurer. All the voting members agree unanimously to keep E.Muniir as the Treasurer.

C.Culligan makes a motion to end the meeting at 8:00. Gonzalez seconds. All in favor. The meeting is adjourned.
