A.Gresham has informed the board that he plans to close the 16U Gresham Travel account since the team has been dissolved.

President's report:

136 girls total have been registered for the spring season.

EHT is registered to participate in ABRSL in spring 2025.

The rec coaches have all been background checked and read to start the season. The rec coaches have received the new 2025 ABRSL Playing rules that are specific for every age group. However, there are some common rules for all the players and coaches to follow. In order to be qualified to participate in the playoffs and championship games, a player is required to make 75% of the games.

Players cannot be pulled from the same age division when guest playing. A guest player can only be brought from a lower age level team. A player playing up must be used only as an outfielder and placed in the bottom of the lineup. All eligible players must play at least 2 defensive innings.

The coaches must have to turn in lineup cards at the end of every game.

Tournaments:

The tournaments are being successfully filled with all the age divisions participating.

Every travel team will have a chance to fundraiser during one of the tournaments. With that said, the fundraising team will be required to have their parents to participate and cover the snack stand duty for the day.
