All accounts, including EHT Operational Account, and all the travel accounts have been moved from TD to Fulton Bank. All accounts have been closed at TD Bank.

VP's Report: JR Gentile suggests to add an amendment to The Bylaws to the Article X, section 3 Traveling Teams.

President's report: Sports connect has replaced SportsEngine, all new sign ups and player tracking will be done through Sports connect from now on.

ABRSL expressed their interest to have EHT come back for the upcoming Spring Ball. Stacy from Folsom is no longer associated with ABRSL. Joining ABRSL in the spring will take pressure of planning and hosting off of EHTYS.

J.Gonzalez and E.Muniir are wondering if joining Little League is a possibility. C.Culligan is planning to meet with a LL representative in the near future to get more info on the process and regulations.

All Stars: EHT can pick between joining District 1 or District 2 for the All Stars. The board members haven't made their final decision; however, one has to be made soon.

Travel: C.Culligan and E.Muniir suggest that in the best interest of the organization, EHTYS should go back to the the pay at the plate option for the future tournaments.

JR Gentile suggested investing in a John Deer field groomer. Per last inventory, we will need to purchase a new flat top grill as well.

New field times availabilities for practices will be as follows, 5:30-7:30, 7:30-9:30.

COBA folded as of 10/16/2025. The Executive Board members (JR Gentile, C.Culligan, J.Gonzalez and E.Muniir) came to an agreement to close their travel account t Fulton and transfer the remaining funds into the main operational account.

N.Schafer's team 12U Beard took 2 players from the folded COBA team, therefore team Beard has received \$600 (\$300 per joining player) transferred to their account to cover those players' tuition.

However, after having placed two players from the folded COBA team, the rest of their players were left with no team. The former COBA parents are outraged and are demanding refunds. No refunds were issued, and the matter was presented for the EHT Rec Board to discuss further.

April 25 - Bombs for Brady - after having heard V.Glick's story about her little nephew battling neuroblastoma, the EHTYS Board has made a unanimous decision to support this local family

during a difficult time. The proceeds from the ornament will be donated to help Brady's family cover medical expenses. Such a gesture will be a great way to open the season, connect with the community and set an example how a local sports organization should operate.
